#### **What do the legal fees cover?**

Our fees cover the following work: -

- Preparing a completion statement and ensuring there are sufficient funds available from you and the Lender on completion
- Completing and dealing with registration of the new charge at the land registry

### **What disbursements should I expect?**

The disbursements that may be likely to be charged for a remortgage transaction are:

- Local search and drainage search and environmental search and/or no search indemnity insurance

### **Other likely costs and Expenses**

A bank charge for redeeming any existing mortgage or for sending funds to your bank account if necessary. This will cost £35.00 plus VAT per transaction.
